# 1. Envision Broad Ripple developments, BR-AVE plans and petitions

Sharon reported on the plans for re-engineering of Broad ripple Avenue and the petition which has been circulating. Funds amounting to about \$34,000 have been raised thus far for: design work for Avenue reengineering plans, a green street cleaner and a four-month study regarding feasibility and usability of a shuttle service in the Village, as well as some reserve funds to help support the Lilly Day of Service in the Midtown area (including Broad Ripple, MKNA and BTNA)

### 2. Update on the Fire Station

Sharon reported that signatures are being sought from the public to encourage the City to consider maintaining a safety presence in the Village. The petition, a copy of which is attached, states:

Director of Public Safety for Indianapolis, Scott Newman, has assured Broad Ripple residents and businesses that no decisions regarding the fate of our beloved firehouse shall be made without the involvement and consent of our community.

**We, the undersigned**, applaud this announcement and urge Director Newman and city officials to elevate this statement from <u>promise</u> to <u>policy</u>. We call on our elected leaders to make community involvement in key decisions the letter of the law. We also believe:

- -Our firehouse is critical to public safety in our neighborhood
- -Our firehouse is the last civic building remaining in a densely populated commercial area; the grounds form a public space used for rallies, meetings, and community events
- -Our firehouse is ideally located for future increased civic services within Broad Ripple Village

All committee members are urged to sign the petition and to encourage others to join you. Mike Seufert, Chair of the BRVA Public Safety Committee, has convened a group to develop a strategy for working with the City to save the station.
