#### 1 Fire Station update

There was no update on the status of the fire station itself, although Diane mentioned that the Indianapolis Fire Department website had information on all the Fire Stations.

Regarding our application for National Register status, Mark Dollase with Historic Landmarks will send a list of qualified professionals to assist with the nomination process. HLF has a mini grant program which could help the committee cover a portion of the costs for hiring this out. He indicated that professional assistance could cost from \$2500 to \$4000, depending upon how much research work would need to be done.

The Committee agreed that getting competitive bids would be in the best interests of the group. Chris will get the estimates.

We would need to raise the balance of the funds, and there followed some discussion on how that would be accomplished and who the donors might be. Several suggestions were recorded including:

Asking area businesses and individuals to donate (individual list recorded separately)

Having a fund raising event

Putting canisters around for cash donations

In compiling a donor list, the Committee tried to steer clear of businesses which support just about everything in the Village in order to give others a chance to participate. BRAP does not have any funds for this, but donations to this project would be made to BRAP where a special Historic Broad Ripple account has been established. Gifts would be tax deductible.

It was suggested that something could be put in the Gazette mentioning the need for funds for this. Alan H stands ready to help when the time comes.

# 5. Broad Ripple Canal

A meeting was held Tuesday evening September 8<sup>th</sup> at Butler to discuss the Water Company's plans to alter the banks of the canal from College Avenue in Broad Ripple to 52<sup>nd</sup> Street near Butler by removing vegetation and adding rip-rap to control erosion. Concerns include eradication of wildlife, altered pH of the water due to the limestone chunks, destruction of vegetation and habitat, reducing the beauty of the canal path for walkers, runners and cyclists.

Chris noted that the Canal is designated as an American Water Landmark by the American Water Works (per the Fayette Street Conservation District documents). Furthermore, in this website from the American Water Works Association it is noted that the Indiana Central Canal in Indianapolis was named a Landmark in 1971. <a href="http://www.awwa.org/Membership/Content.cfm?ItemNumber=498&navItemNumber=1458">http://www.awwa.org/Membership/Content.cfm?ItemNumber=498&navItemNumber=1458</a>. This may enable the canal to be protected as an historic structure. The next meeting for public comment on the Canal will be Monday, September 14, 7 PM in the Broad Ripple High School Auditorium. All committee members are encouraged to attend.

This will be in two years. The celebration will be planned by the BRVA; members of the Committee for Historic Broad Ripple should be thinking about ideas and ways to help in the celebration. Perhaps that committee would morph into the 175<sup>th</sup> celebration.
